1. Final STRADE conference in Brussels in October 2018

We concluded the STRADE dialogue with our one-day final conference in Brussels with over 80 participants attending. In four sessions the STRADE team briefly outlined the major STRADE recommendations, followed by extensive discussions with panellists and the audience on the following key areas:

 Materials Engagement Lessons from STRADE



The STRADE team, following-up on the results of the discussion,
